3. The full copy or reproduction, as well as the partial or complete reproduction of images, from our holdings require the express consent of the Rudolf Steiner Archive. This permission has to be requested in written form and it is absolutely necessary in case of records that are still subject to copyright and which have not been published yet.
4. In publishing documents from our holdings, the Rudolf Steiner Archive has to be mentioned as source and as preservation institution of those holdings, with an accurate specification of the record, including location and reference numbers and the designation: **Rudolf Steiner Archive, Dornach, Switzerland.**
5. The Rudolf Steiner Archive has to be provided with **one copy, unsolicited and free of charge**, for every publication which includes documents of our holdings.
6. The work of Rudolf Steiner is no longer subject to copyright, it is in the public domain, thus its publication does not require any consent. However by using archival records, the Rudolf Steiner Archive has to be mentioned as source and preservation institution of the holdings (See point 3).
7. The invoice is to be paid within 14 days of the invoice date.
